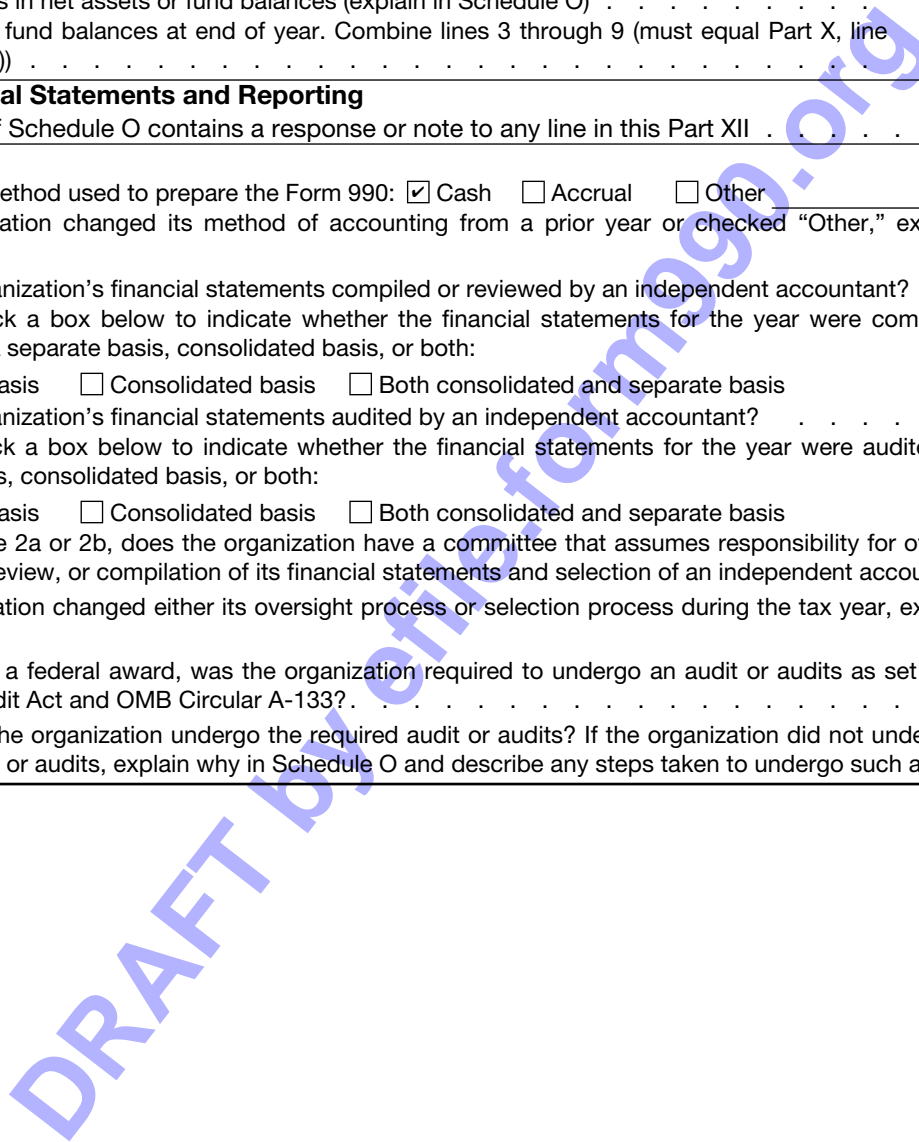

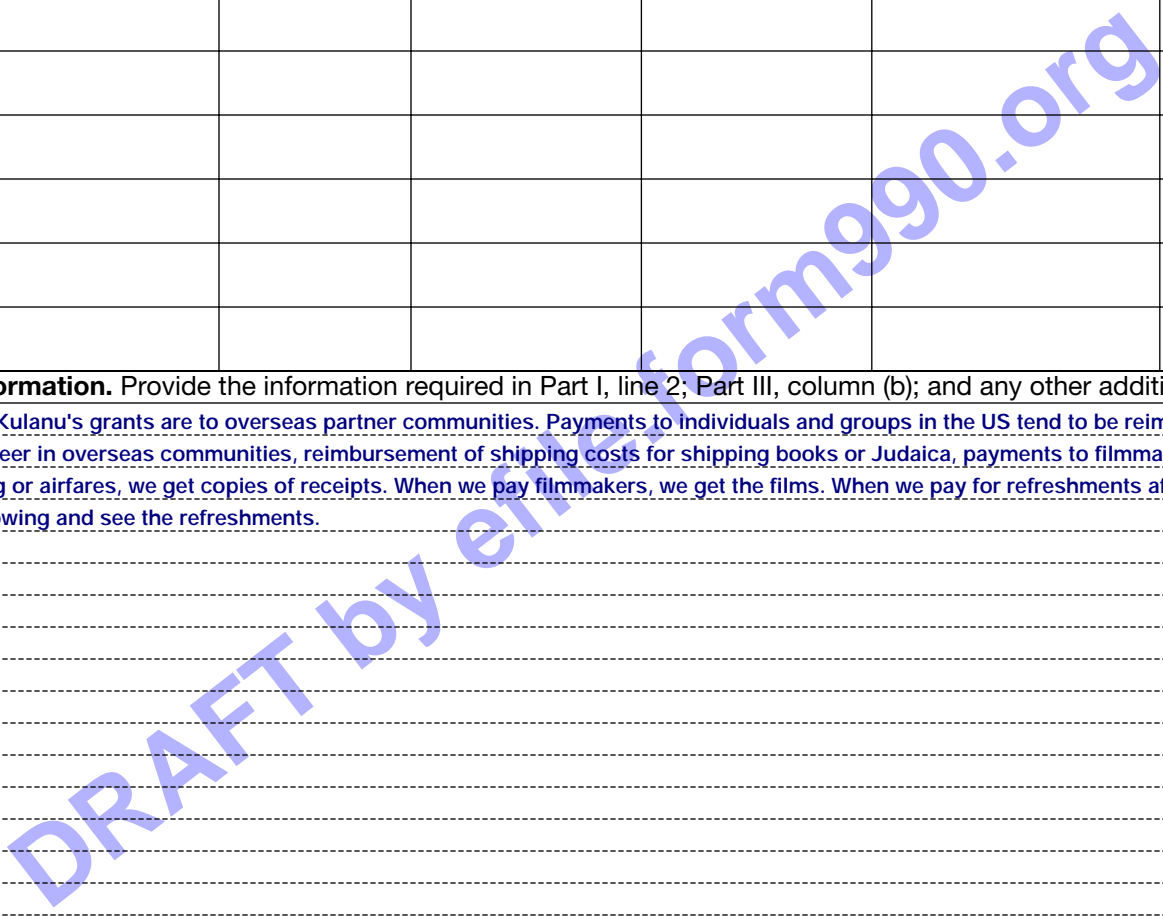

When we reimburse shipping or airfares, we get copies of receipts. When we pay filmmakers, we get the films. When we pay for refreshments after a film showing, our representatives attend the film showing and see the refreshments.
