Religion-related, spiritual development: Abayudaya Jewish community, Uganda. Supported elementary schools, school nutrition program, construction of school kitchen, incinerator, and administrative offices, computer labs in two schools, and award-winning school music and dance program. Sent volunteers. Schools and nutrition program serve Christians, Muslims and Jewish children. Support the education of 6 deaf children.

Religion-related, spiritual development: Lemba Jews of Zimbabwe. Supported: 1) the operations of the Harare Lemba Synagogue, which serves as a synagogue, community learning and nutrition center, 2) Passover and other holiday events in Harare, Mapakomhere, and three other rural villages 3) a music program in which members of the Harare Lemba Synagogue composed, performed, and recorded liturgical music 4) a second water storage dam and a continuing soil conservation project in a rural village and a promising chicken business in Harare 5) paid airfare for two young Lemba leaders to study in Israel for three months in program offered by Ohr Torah Stone yeshiva.

Religion-related, spiritual development: other communities: worked on Judaism and Jewish heritage with communities in Africa (other than Uganda and Zimbabwe), Latin America, and Madagascar. We arranged an extended placement of volunteers in Papua, Indonesia and shorter visits to Nigeria, Zimbabwe, Cote d'Ivoire, Madagascar, Ecuador, Ghana, India, Myanmar, and Kenya. Past travelers report that visits often begin long-term personal relationships, with mutual learning and sharing. In addition to grants to several communities for Jewish learning, education, and technology, our support includes encouraging visitors and volunteers, publicizing news of these communities on our magazine, web site, other social media, and with the press. Kulanu supported several special projects in 2018, including new guest quarters in Abuja, Nigeria named for Rabbi Wayne Franklin of Providence, Rhode Island, and a social hall and kitchen in Kenya. We sent laptops, smartphones, and funds for internet access to leaders in Gabon, Ghana, India, Nigeria, Uganda, and Zimbabwe. These devices and those sent in previous years allow communities to connect. We helped repair old Jewish cemeteries in Suriname and provided emergency funds for families to leave Nicaragua temporarily when conditions were dangerous.
